The regular meeting of the Spring Valley City Council was held in the City Hall Council Chambers and called to order by Mayor Marini at 7:00 p.m. with the following Aldermen answering present to the roll call: Mike Herrmann, Chris Affelt, Fred West, Jeff Janusick, Deb Baltikauski, Ken Bogacz and Dave Pellegrini. Absent: Ed Jauch. 7 present. 1 absent.

All joined in the Pledge of Allegiance to the Flag of the United States of America.

Chief Curran recognized Officer Sarah Kinkin who is being promoted to the position of Sergeant in the Spring Valley Police Department.

John French from Elite Seamless Gutters was present to give an update on the progress of his plans for a new building by Valley Ford. Mike Richetta from Chamlin reported they have been hired by French to prepare a site plan per the city code. He expects the plan to be done and reviewed by Renwick by early next week. French then asked for an extension to get his vehicles moved since the building has been held up due to the need for a site plan and Morton Builders is now 3 weeks out after the permit is issued. Alderman Janusick noted we made a promise to the residents that the vehicle situation would be taken care of and doesn't feel we should be giving any extensions. Alderman Affelt recommends finishing out the 90 day extension that was already given to French on December 20th and then see what progress has been made. Mayor Marini asked Mr. French to give an update to the council on March 8th and again on April 5th.

Mike Richetta from Chamlin reported that a questionnaire needs to be submitted to IDOT for the REBUILD Bond grants noting the city intends to use 100% of the funds. He will take care of the paperwork.

Duane Calbow from NCICG was present to answer any questions regarding the Enterprise zone amendment that is on the agenda this evening.

Alderman Pellegrini noted his Public Health & Safety meeting minutes have been filed with the City Clerk.

Alderman West discussed the Fire Department Aerial Truck repairs and asked that the city authorize \$7439. (or the allowed 15.6% of the cost) from the TIF Fund, \$20,000. from General Fund and the balance from Fire Protection Funds.

Alderman Bogacz asked when the work would begin. Superintendent Norton noted as soon as the weather cooperates probably early spring. It was also noted that the city is not involved with Verucchi culvert issue as it is not in the city limits.

Superintendent Norton noted there have been some issues at the WTP with screens being busted out, switches on the outside of building running in the morning and tire tracks near the plant. He doesn't know why the pant hasn't been fenced in and the cost to do so is about \$23,000. We are going to start by putting in cameras and video surveillance signs.

Mayor Marini presented a plaque to Attorney Jim Andreoni who has served as City Attorney for 28 years. Marini thanked Andreoni on behalf of himself and the city for all his advice and council over the years. Attorney Andreoni thanked those who have served in an elected position over the years for their work and all they do for the community.

Mike Richetta from Chamlin reported on the French site plan review we received from Renwick and Associates. Richetta responded to Renwick's questions and feels everything has been covered. Renwick reviewed Richetta's responses and have no additional comments. Richetta also discussed the Rebuild bonds noting he submitted suggested projects to IDOT and suggested the Alderman start looking at eligible streets.

Alderman Pellegrini reported he had an opportunity to meet with Pinter Construction to tour the old hotel which set him back as it is truly a mess. Pinter gave an estimate of \$12,666. to clean out the building including old appliances, furniture, garbage and animal droppings. The fee would also include four new doors with dead blots and locks. Pellegrini feels the building can be rehabbed if someone knows what they are doing and believes we should have Pinter clean the building out if we think we can find someone to rehab it. There was some council discussion and the feeling was to have Pinter do the cleanup. Pinter's estimate will be put on the next agenda.
