Greenwood Street, Spring Valley, Il. 61362 and called to order by Mayor Malooley Thompson at 7:00 p.m. with the following Aldermen answering present to the roll call: Mike Herrmann, Chris Affelt, Jen Diaz, Greg Campbell, Deb Baltikauski, Ken Bogacz and Dave Pellegrini. Absent: Ed Jauch. 7 present. 1 absent.

All joined in the Pledge of Allegiance to the Flag of the United States of America.

#14297 Moved by Alderman Baltikauski and seconded by Diaz that we dispense with the reading of the minutes of the last regular meeting and approve them as presented. Aye votes: Herrmann, Affelt, Diaz, Campbell, Baltikauski, Bogacz and Pellegrini. 7 ayes. Motion carried.

Mike Richetta from Chamlin and Associates reported the street work is done for now but noted they may need to go back and add dirt and seeding after winter.

Jeff Norton noted he would like to get rid of some equipment that is no longer in working condition. An ordinance is on the agenda this evening to approve the disposal. Norton also noted leaf pickup will be done at the end of the week, one of our Street employees is retiring next year and he would like to find someone for replacement so he can get trained now and he noted Luke Foster will not be going to the parks next season.

Mayor Malooley Thompson thanked Jen Diaz for getting letters out to the businesses for our grant application as well as 90 letters from residents through JOT on our facebook page.

Alderman Baltikauski asked for an update on the issue with Aperion Care. Superintendent Norton noted nothing has been done yet and the new lift station is handling it now but it won't long term. Attorney McClintock will look into the penalties if nothing is done and send a letter to Aperion Care. Baltikauski also asked for an update on the auto read meter installation and it was noted we still have approximately 1000 left to install.

Alderman Bogacz asked for an update on Well #10. Superintendent Norton reported we are waiting on pump parts and he hopes they will have it back up and running by Christmas. We will discuss an agreement for a contract once the well is fixed.

The were no petitions received for consideration.

Curran thanked citizens and businesses that supported the Police Departments Holiday Extravaganza at JFK and also reported the department purchased Christmas gifts (noting Walmart Distribution was a big contributor to the gifts as well) for 12 children thru the Shop with a Cop program. Chief Curran also announced Spring Valley is one of seven cities in the United States with a population less than 10,000 to receive the National Night Out Cup in recognition of the department's coordination of activities for this Summers National Night Out Event.

Jeff Norton reported the leaf pickup program is done for the year.

Mike Richetta from Chamlin and Associates would like to discuss issues that still need to be addressed in reference to the CSO meeting including headworks and the Fourth Street watermain replacement at the next Water and Sewer committee meeting which will be scheduled in January and then noted paperwork needs to be filled out for the 2019 Capita bill in the amount of \$150,000. which was originally submitted for street scaping and way finding signs but has been changed to street infrastructure and capital improvements.
