REGULAR COUNCIL MEETING JULY 19, 2021

The regular meeting of the Spring Valley City Council was held in the City Hall Council Chambers, 215 N. Greenwood Street, Spring Valley, Il. 61362 and called to order by Mayor Malooley Thompson at 7:00 p.m. with the following Aldermen answering present to the roll call: Mike Herrmann, Chris Affelt, Greg Campbell, Deb Baltikauski, Ken Bogacz and Dave Pellegrini. Absent: Ed Jauch. 6 present. 1 absent.

All joined in the Pledge of Allegiance to the Flag of the United States of America.

City Clerk Hansen administered the Oath of Office to Jennifer Diaz (2nd Ward Alderman).

The following reports (2) were received and placed on file:

- #14196 Moved by Alderman Affelt and seconded by Bogacz that we dispense with the reading of the minutes of the last regular meeting including minutes of the Public Hearing held on July 6, 2021 and approve them as presented. Aye votes: Herrmann, Affelt, Diaz, Campbell, Baltikauski, Bogacz and Pellegrini. 7 ayes. Motion carried.

Mayor Malooley Thompson reported a volunteer recently cut a large hazardous tree down for the city and trimmed trees in the mini park. The Mayor noted several volunteers have reached out to her and she welcomes and thanks them. Mayor Malooley Thompson we be hosting a "Meet the Mayor" on July 26, 2021 for Businesses to discuss growth and concerns. She is also working with Jen Heredia to rename the SV Booster Organization to Grow Spring Valley, looking into a Property Management Program, meeting with Alderman Baltikauski to review ordinances, noted Alderman Campbell is working on a sidewalk program and Alderman Bogacz is working with Mike Richetta on a long-term street program.

Mayor Malooley Thompson appointed Teresa Case to the Park Board.

Mike Richetta from Chamlin and Associates reported MFT program has been submitted to IDOT for approval, the Greenwood Street sewer project is waiting on a pre-construction meeting, NCICG didn't receive any bids for the demolition of two houses at the bid opening and they have reached out to a few contractors for quotes which is fine with the grant as long as we are following city guidelines which includes a Responsible Bidder Ordinance. Richetta has sent a memo to the Mayor and City Attorney in regards to the demolitions and is awaiting direction.

Mayor Malooley Thompson asked for a motion to open the Public Hearing on the 2021–2022 Appropriation Ordinance.

The tentative Appropriation Ordinance was available in the City Clerk's office and discussed at a previous meeting. There were no comments or questions from the City Council or Public.
