REGULAR COUNCIL MEETING NOVEMBER 2, 2020

The regular meeting of the Spring Valley City Council was held in the City Hall Council Chambers and called to order by Mayor Marini at 7:00 p.m. with the following Aldermen answering present to the roll call: Mike Herrmann, Ed Jauch, Chris Affelt, Fred West, Jeff Janusick, Deb Baltikauski, Ken Bogacz and Dave Pellegrini. 8 present.

All joined in the Pledge of Allegiance to the Flag of the United States of America.

The following report was received and placed on file:

Mayor Marini expressed his sympathy to the Slover family who lost a family member and home in a house fire. He thanked the Fire Department and Police Department who tried to rescue Mrs. Slover but were unable to.

Superintendent Norton reported the Ladd Road and 4th Street storm sewer was lined last week, smoke testing in Cambridge will be finished next week, the Street Dept. will be overseeing the Fiber Optic installation coming through town and they will also be working on cleaning out the Willow Court retention pond.

Mayor Marini discussed the recent Governors order regarding bars and restaurants. The Mayor noted after speaking with Chief Curran and the City Attorney the best route for the city to take is not site anyone but anyone not following the guidelines will documented and sent to the IDPH, State Police and States Attorney. Chief Curran noted he doesn't believe the city has the authority to shut down any business not following the guideline but he will document those and let the State decide how to proceed.

Chief Curran reported commendations for several officers were included in the packet as he feels they do fine work and should be recognized. Mayor Marini also mentioned Peru Police Chief Doug Bernabei sent a nice letter commending several officers of the Spring Valley Police Department.

Economic Director Ladgenski noted we cancelled our Christmas in the Valley and lighted parade mostly due to control of the crowds that may be attending. Several Businesses are working together to have something to promote local shopping on November 13 & 14.

Alderman Herrmann reported on a Finance committee meeting held on October 26, 2020 at which time John French spoke to the council about purchasing property and putting a building on site for his vehicles. He also asked for an extension to get his vehicles off the city streets and was granted 3 months as long as he keeps up his side of the agreement and follows through with the plan. Other discussion included stopping the portion of Utility Tax going into Capital Improvement until the fund is depleted to \$100,000. which would help add to the general fund, loan documents for the auto read water meters which we hope to receive a CURES grant to repay the loan, SVPD contract with NexisLexis for accident reporting and a multi jurisdiction understanding for mental health to handle situations where mental health issues are involved

Alderman Baltikauski reported on a Legislative Committee meeting held on October 26, 2020 at which time discussion included the deputy chief position and whether or not to keep it or eliminate it. We will keep it at this time.

Alderman Baltikauski scheduled another Legislative committee meeting for Monday, November 11, 2020 at 6:30 p.m. to discuss the current façade application and regulations, suggested park board rules and any other matters that may come before the committee.

Mike Richetta from Chamlin discussed a code review proposal from Studio K Architecture for 228-230 E. St. Paul St. The proposal will be on the next agenda for approval.

Superintendent Norton reported the leaf program is still ongoing but moving slow due to the large amount of leaves. He will continue to pick them up as long as weather permits. Alderman Janusick asked if it would be cheaper to hire someone to pick them up. Norton is not aware of anyone who does that type of work.

Alderman Herrmann reported on a Finance committee meeting held on November 9, 2020 at which time the meeting was planned to discuss the proposal for renovation of 228-230 E St. Paul St. but Mr. Hince was unable to attend.
