REGULAR COUNCIL MEETING MARCH 7, 2022

The regular meeting of the Spring Valley City Council was held in the City Hall Council Chambers, 215 N. Greenwood Street, Spring Valley, Il. 61362 and called to order by Mayor Malooley Thompson at 7:00 p.m. with the following Aldermen answering present to the roll call: Mike Herrmann, Ed Jauch, Chris Affelt, Jen Diaz, Greg Campbell, Deb Baltikauski, Ken Bogacz and Dave Pellegrini. 8 present.

All joined in the Pledge of Allegiance to the Flag of the United States of America.

Mayor Malooley Thompson introduced Laura Dubberstine and Danielle Wildhart who addressed the council in regards to their vision for a Youth Center in Spring Valley. They believe it would be a positive plan for the community and for our youth. Mrs. Dubberstine asked the city council for support and use of the community room on Sundays for the next 3 months to build up the group.

#14348 Moved by Alderman Baltikauski and seconded by Campbell that we dispense with the reading of the minutes of the last regular meeting and approve them as presented. Aye votes: Herrmann, Jauch, Affelt, Diaz, Campbell, Baltikauski, Bogacz and Pellegrini. 8 ayes. Motion carried.

Superintendent Norton reported Waste Water Treatment Plant Operator, Rob Baracani, is having issues at the WWTP with the blower unit and disinfection system. These items are on the agenda this evening for approval. Alderman Bogacz asked if these items have met their life expectancy and Supt. Norton noted per Rob they are beyond their design service life. Norton also suggested we need a plan to allocate funds for these general maintenance issues. Superintendent Norton also reported he has found a bucket truck noting the cost will come out of the Equipment Depreciation Fund from equipment he sold in the fall.

Chief Curran reported he has received the National Night Out plaque, thanked Walmart for a \$5000. donation for Police Community Relations, thanked Upscale Resale for a \$2500. donation for National Night Out and the Shop with a Cop program and he will be presenting a scholarship of \$500. each to a student from Hall High School and St. Bede Academy which will be determined by community service hours and an essay. Chief Curran also commended Officers Kinkin and Pellegrini for their recent investigation work.

Mike Richetta from Chamlin and Associates reported he has a list of projects for the \$150,000. Capital Grant which needs to be discussed and submitted by the end of April.

Mike Richetta from Chamlin and Associates reported he is 50% complete on the Street inventory and 50% complete on the design for the 4th Street project which he will review with Superintendent Norton and send to EPA for permit.

Mayor Malooley Thompson reported she is working with JC Heerdt on website issues and will be working on email addresses next. The Mayor also reported she will be attending an IVAC Meet the Mayor event on March 31st at Grand Bear Lodge and invited any City Official to attend if they would like.
