REGULAR COUNCIL MEETING OCTOBER 3, 2022

The regular meeting of the Spring Valley City Council was held in the City Hall Council Chambers, 215 N. Greenwood Street, Spring Valley, Il. 61362 and called to order by Mayor Malooley Thompson at 7:00 p.m. with the following Aldermen answering present to the roll call: Mike Herrmann, Ed Jauch, Chris Affelt, Jen Diaz, Greg Campbell, Deb Baltikauski, Ken Bogacz and Dave Pellegrini. 8 present.

All joined in the Pledge of Allegiance to the Flag of the United States of America.

There were no public comments on agenda items.

#14505 Moved by Alderman Baltikauski and seconded by Diaz that we dispense with the reading of the minutes of the last regular meeting and approve them as presented. Aye votes: Herrmann, Jauch, Affelt, Diaz, Campbell, Baltikauski, Bogacz and Pellegrini. 8 ayes. Motion carried.

Alderman Bogacz reported about 50% of the sidewalk program for this year are complete.

Alderman Baltikauski reminded the council that we need a Capital Improvement Plan Committee and Alderman Affelt and Alderman Diaz volunteered to be on the committee.

Superintendent Norton reported spray patching is done for the year unless he can get emulsion from another plant and they are still working on the west interceptor project but it is moving slow. He also noted Well #10 has been down for about a month now and though he has been talking to our contracted maintenance company about twice a week he has been getting nowhere. The council asked Norton to make sure to document all communications. City Attorney Colin Barry will follow up with them.

Police Chief Curran reported we have been awarded a bullet proof vest grant that reimburses 50% of the cost.

Mike Richetta from Chamlin and Associates noted the 4th Street Water Main project should begin this fall.

The regular meeting of the Spring Valley City Council was held in the City Hall Council Chambers, 215 N. Absent: Dave Pellegrini. 7 present. 1 absent.

All joined in the Pledge of Allegiance to the Flag of the United States of America.

Kiera Gavin from Geranium Solar was present to thank the City and Planning Commission for their time in regards to a variance and special use permit for a proposed solar farm on the west edge of town. Ms. Gavin gave a brief sense of the project noting one access road, seeding under and around to minimize runoff issues, minimal concrete, a 7' chain link fence, a vegetated screening on the southern side, explained decommission/removal at the end of the lifetime. Ms. Gavin also noted a tax benefit to the city during the lifetime of the project.

Alderman Bogacz noted curb and gutter work on St. Paul Street which was a part of the \$150,000 grant has been added to the MFT project so it can get done with road work and we will not have to tear up the road later with the Capital grant project.

She also discussed the property tax increase over the life of the solar farm and when asked if they would use local labor she noted there are no contracts at this time but it would make sense to use local.
