All joined in the Pledge of Allegiance to the Flag of the United States of America.

Norton also reported leaf collection is behind schedule due to equipment issues, he is searching for a dump truck and will continue to look but there are not many out there and the two trucks he ordered are behind and he hasn't been able to get them.

Mike Richetta from Chamlin and Associates reported the street program has made good progress and is about 85% done. They will be working on Pulaski and Thorn Streets tomorrow and the Oak Street drainage work is done.

Mayor Malooley Thompson noted she has had experience with both companies who do a good job but noted Troy Technologies is a local business and their quote is a savings to the city. There was council discussion and it was decided to go with Troy Technologies.
