# REGULAR COUNCIL MEETING SEPTEMBER 5, 2023

The regular meeting of the Spring Valley City Council was held in the City Hall Council Chambers, 215 N. Greenwood Street, Spring Valley, Il. 61362 and called to order by Mayor Malooley Thompson at 7:00 p.m. with the following Aldermen answering present to the roll call: Mike Herrmann, CJ VanSchaick, Chris Affelt, Jeff Chiaventone, Greg Campbell, Deb Baltikauski, Ken Bogacz and Dave Pellegrini. 8 present.

All joined in the Pledge of Allegiance to the Flag of the United States of America.

There were no public comments on agenda items.

#14725 Moved by Alderman Herrmann and seconded by VanSchaick that we dispense with the reading of the minutes of the last regular meeting. Aye votes: Herrmann, VanSchaick, Affelt, Chiaventone, Campbell, Baltikauski, Bogacz and Pellegrini. 8 ayes. Motion carried.

Mayor Malooley Thompson reported she recently attended a Rotary meeting and gave an update on what is happening in Spring Valley.

Chief Curran reported we received training reimbursement from the State for 2 of our officers. He also noted a commendation letter was presented to Deputy Chief Kinkin, Officer Pellegrini, Officer Behrens and Officer Piercy in regards to the Mean Metal Gun burglary case.

Superintendent Norton discussed an issue over the weekend that continued into today with a landlord digging up and replacing a water line and sewer that was connected to a neighbor causing the neighbor to be without water or sewer. There was council discussion and the mayor will discuss with the City Attorney to get the issue resolved.

Mike Richetta from Chamlin and Associates reported there is an inventory grant opportunity to do GIS mapping of the water system. NCICG fee to prepare the grant application is \$750. The council agreed to move forward with the grant application. Richetta also noted he will have bid packets ready by the end of the week for the old hotel demolition.

Alderman Bogacz asked when Ace in the Hole will be back to finish the spray patch on Greenwood St. Richetta noted they ran out of material and will be returning to finish the job but are behind on other jobs as well.
