Greenwood Street, Spring Valley, Il. 61362 and called to order by Mayor Malooley Thompson at 7:00 p.m. with the following Aldermen answering present to the roll call: Mike Herrmann, Jeff Chiaventone, Greg Campbell, Deb Baltikauski, Ken Bogacz and Dave Pellegrini. Absent: C.J. Vanschaick and Chris Affelt. 6 present. 2 absent.

All joined in the Pledge of Allegiance to the Flag of the United States of America.

There were no public comments on agenda items.

Superintendent Norton noted a portion of the recommended Caroline Street is in need of a new watermain and suggested we don't fix the street only to tear it up when we replace the watermain.

Superintendent Norton noted they are still picking up leaves though the machine is not 100% functional. He has looked into purchasing a new leaf machine which is very costly at about \$332,000. The machine would also double as a branch chipper when needed and Norton feels it would last 20 years and will save labor and fuel. He will look into a lease option for the machine if available.

Deputy Chief Kinkin reminded the council that the next adjudication hearing is scheduled for December 12, 2023.
