### REGULAR COUNCIL MEETING FEBRUARY 5, 2024

The regular meeting of the Spring Valley City Council was held in the City Hall Council Chambers, 215 N. Greenwood Street, Spring Valley, Il. 61362 and called to order by Mayor Malooley Thompson at 7:00 p.m. with the following Aldermen answering present to the roll call: Mike Herrmann, C.J. VanSchaick, Chris Affelt, Jeff Chiaventone, Greg Campbell, Deb Baltikauski and Ken Bogacz. Absent: Dave Pellegrini. 7 present. 1 absent.

All joined in the Pledge of Allegiance to the Flag of the United States of America.

There were no public comments on agenda items.

The following report was received and placed on file:

- #14817 Moved by Alderman Bogacz and seconded by Herrmann that we dispense with the reading of the minutes of the last regular meeting. Aye votes: Herrmann, Van Schaick, Affelt, Chiaventone, Campbell, Baltikauski and Bogacz. 7 ayes. Motion carried.

Alderman Affelt reported on a Housing Rehab Grant Committee meeting held this past Friday noting NCICG will be starting the next years grant applications and they will be sending the paperwork approving NCICG to prepare and submit the grant application for the agenda in the near future.

Alderman Bogacz gave an update on the last Streets and Alleys committee meeting at which time distributed a handout with streets that he has been looking at with Mike Richetta for the Street program. Bogacz also discussed a possible chip and seal to be used on some roads which would be a cost savings and a preventative maintenance. Richetta noted there are some issues with the chip and seal as it is dusty and can be messy but it is an option if the city chooses. Alderman Bogacz asked if the council would like to consider this method noting we can do more streets also noting Ladd uses the chip and seal and the streets are nice. The council would like to look into it and consider the chip and seal.

Chief Curran reported on several items including one of his oldest trucks in his fleet had an engine blow but fortunately it was still under warranty, the new squad is waiting for parts to get outfitted, the body cameras have been installed and new officer Ralphie Romo is in week 5 of 16 and maintaining an A average.

Mike Richetta from Chamlin and Associates reported the asbestos abatement has started at the old hotel but the tear down is behind due to the weather. The contractor is looking for an extension to the end of March but Richetta suggested a 20-day extension. Mayor Malooley Thompson suggested giving an extension to March 15, 2024. McKee Environmental will do a final assurance test once the abatement is finished. Richetta also handed out a list of projects noting NCICG will submit 2 of the projects for possible grants. Richetta will add the mini park improvements to the list.

Alderman Bogacz noted with all the snow we've had recently should we have an ordinance requiring vehicles get off of city streets after a large snowfall and abandoned vehicles should be moved within a certain number of days. Chief Curran noted there is an ordinance with snow routes on certain streets and an abandoned vehicle ordinance

and asked that any Alderman who has concerns regarding either of these to please let him know and he will address them.

Alderman Pellegrini asked for the status on the demolition of the old hotel. Mike Richetta gave an update noting the demolition date was extended to March 15, 2024. He also reported the asbestos investigation was done by McKee Environmental, Inc. for a fee of \$800. and it came back clean. Mr. Liebhart will be notified and asked if anyone is in his building located next to the old hotel prior to demolition beginning.

Superintendent Norton reported shortly after the earthquake several months ago they are finding sand in Well #10 and seeing it at the WTP. He has been talking to the sand filter people and waiting for Tech Clean to look at it. He will keep the council informed.

Chief Curran reported the body cameras are installed and they will be doing trial runs and understanding the system noting they are still a few months out before they are running. He also noted he received the National Night Out Award today.

Richetta noted that WTP Operator Hal Entwistle has about 95% of the inventory done and it will be beneficial to the city in the long run. He is hoping the entire town can be done with the grant.
