REGULAR COUNCIL MEETING MARCH 3, 2025

The regular meeting of the Spring Valley City Council was held in the City Hall Council Chambers, 215 N. Greenwood Street, Spring Valley, II. 61362 and called to order by Mayor Malooley-Thompson at 7:00 p.m. with the following Aldermen answering present to the roll call: Mike Herrmann, C.J. VanSchaick, Chris Affelt, Jeff Chiaventone, Greg Campbell, Deb Baltikauski, Ken Bogacz and Dave Pellegrini. 8 present.

All joined in the Pledge of Allegiance to the Flag of the United States of America.

There were no public comments on agenda items.

#15097 Moved by Alderman Baltikauski and seconded by Herrmann that we dispense with the reading of the minutes of the last regular meeting and approve them as presented. Aye votes: Herrmann, VanSchaick, Affelt, Chiaventone, Campbell, Baltikauski, Bogacz and Pellegrini. 8 ayes. Motion carried.

Mayor Malooley-Thompson reported we had a large water main beak over the weekend and while Superintendent Norton was working to get it stopped and fixed, in the future we will get notification out to our residents as soon as possible via Facebook and or code red notification. Mayor Malooley-Thompson also reported she has reached out to IVAC to schedule an after hours in November at the new Community/Event Center, Steve Lamis has purchased and will be renovating the Tonozzi building to relocate his Edward Jones office, the Gold Mine will be expanding into the previous Edward Jones location, and Valley Coin and Pawn will be relocating into the previous St. Margaret's Billing Center.

Alderman Pellegrini reported that Keith has started back today and has begun working on the baseball field, batting cages, bathrooms and dog park. The Pickle Ball Court will be open in a few weeks.

Alderman Herrmann scheduled a Finance Committee meeting for March 10, 2025, at 6:30 p.m. to discuss various grants, water main replacements, Barto Landing, Community/Event Center, Well #10 rehab, city portion of Peru Princeton Road maintenance and any other matters that may come before the committee.

Chief Curran reported the first Flock camera has been installed noting that 4000 cars went by in one day and he is working on a security grant through the State.

Mike Richetta from Chamlin and Associates gave an update on the Barto Landing dredging and also noted the west Interceptor Project is nearing completion.

Superintendent Norton received an email informing him IDNR will be coming to Coal Miners Park next week to survey, Pohar will be doing some repairs on Greenwood Street between Fourth and Fifth Streets before we have any more issues (we will go door to door and let the residents know), Clegg Perkins Electric has sent an estimate for stop light repairs at Walmart and 89, and Rt 6 and 89. The stop light repairs were discussed and Alderman Pellegrini noted it needs to be done.

She also asked the city for a donation to the youth center and for the installation of carpet in one area of the room and also noted volunteers are needed. Mayor Malooley-Thompson has found a donation of a couch and chair and donated bean bag chairs to improve the space. The mayor also noted they need some assistance with a sound barrier and partitions. Alderman VanSchaick feels it gives the kids something to do as well as guidance.

Alderman Pellegrini reported on a park board meeting at which time the primary focus was on the Summerfest and Carnival. Tickets for the carnival are available at the City Clerk's office at a cost of \$60 for all 4 days, which is a very good deal.

Superintendent Norton reported he has had some water issues at the former Hobbs building and is continuing to locate a shut off valve. He will be shutting off water tomorrow morning for residents on 900 block of west 2nd, 3rd and 4th St. to test the issue – residents will be notified prior to shut off. He is getting new estimates for easy valves for the location if needed.
